2 (13.02.2014) The land is subject to the following agreement and declaration contained in a Conveyance of the freehold estate in the land in this title dated 25 March 1972 made between (1) The Manchester Ship Canal Company (Vendors) and (2) Stretford Corporation:-

"IT is hereby agreed and declared by and between the parties hereto that the Vendors shall have the right to discharge storm water from the land retained by them on the North side of Barton Dock Road aforesaid comprising an area of 9 acres or thereabouts into the existing culvert on the land hereby conveyed or into any alternative drainage system constructed thereon."

3 (13.02.2014) The land is subject to the rights of drainage reserved by a Transfer of the freehold estate in the land in this title dated 12 July 1973 made between (1) Stretford Corporation Corporation and (2) the Secretary of State for the Environment.

4 (13.02.2014) The parts of the land affected thereby are subject to the leases set out in the schedule of leases hereto. The leases grant and reserve easements as therein mentioned.
